Our energy healing sessions are a confidential process designed to help you address your concerns, come to a greater understanding of yourself, and learn effective personal and interpersonal coping strategies. It involves a relationship between you and me, Aaron Gustwiller, who has the desire and willingness to help you accomplish your individual goals. These sessions can involve sharing sensitive, personal, and private information that may at times be distressing. During the course of our sessions, there may be periods of increased anxiety or confusion. The outcome of the session is often positive; however, the level of satisfaction for any individual is not predictable. I am here to help you to release, change and improve your life as you transition into a new you.

TRAINING

Aaron Gustwiller is a certified practitioner within the energy healing modalities of a Reiki Master and he also uses techniques learned in his training within the Shamanic traditions. He has taken psychic and mediumship courses to enhance his skills to help his connection to the other side for your healing.

DESCRIPTION OF A HEALING SESSION

Aaron uses his abilities to read your chakras or energy centers to identify with any stuck energies. These energies come to him as emotional issues, but are not limited to just that. As mentioned above, he isn't a doctor, but on occasion he has been able to identify with physical issues within the body of some clients. This is referred to as being a medical intuitive. He will only suggest that you ask a professional health care provider for further information. He works with his spirit guides and sometimes the client's loved ones from the other side that show up for support or to help in the healing process. Aaron states a word or asks questions that with your cooperation can relate to within your own life. This starts the conversation towards understanding what you as the client needs to heal from. **The most important conversation that you can ever have is with yourself.** This is what Aaron will help you to do to better understand yourself and help you in ways to feel better emotionally. **Since this is a discussion with yourself through me, you are in control of your healing session. If wish to stop the session or change the subject of discussion, let me know so that changes in treatment can be made.** Aaron may give you homework to do to help you in your healing process and or ways to improve your life. This is important to do for your own success, but it is your decision to do so.

BENEFITS AND RISK

A session provides various sensations during and after a session depending upon the topic or issues covered. Clients may sometimes experience an increased flow of energy throughout their body and personal space creating an increased sense of well-being. As well, energy work may bring about the release of old emotions such as grief, sadness or anger as part of the healing process and may also bring forward outdated energetic patterns, including but not limited to, relationships with work, friends and family members. Clearing such imbalances in your subtle body may be reflected in your relationships with others and the world. Clients often find it appropriate to relax right after a session and allow the integration of the energy work to continue. Drinking water and relaxing allows the body to eradicate old toxins and energy and provide the body to integrate the energetic alterations.
